Dear Sir,

I, Shyamprasad D Limaye, a Company Secretary in practice (Membership No. FCS 1587 & CP 572) have been appointed by the Board of Directors of Bajaj Auto Limited ("the Company") as a Scrutiniser for the purpose of scrutinising the remote e-voting ('e-voting') and ascertaining the requisite majority on e-voting carried out as per the provisions of Section 108 and Section 110 of the Companies Act, 2013, read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended, on the resolution contained in the Postal Ballot Notice dated 08th January, 2024 ("the resolution").

- 1. There were no postal ballot forms sent to the members in view of the guidelines prescribed by the Ministry of Corporate Affairs ("MCA") for conducting postal ballot process through e-voting, vide General Circulars issued from time to time (the 'MCA Circulars').
- 2. The notice dated 08th January, 2024, seeking approval of members of the Company along with statement setting out material facts under Section 102(1) of the Companies Act, 2013 was sent to the members through e-mail in respect of the resolution to be passed, through postal ballot via remote electronic voting ('e-voting') through the electronic voting platform provided by KFin Technologies Limited ("KFin")...
- 3. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules made thereunder, SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and such other applicable provisions relating to postal ballot through remote e-voting on the resolution for approval of the members of the Company. My responsibility as a Scrutinizer for 'remote e-voting' is restricted to make a Scrutinizer's report of the votes cast in "favour" or "against" of the resolution and "invalid" and "abstained" votes, based on the reports generated from the e-voting platform provided by KFin.
- 4. Further to the above, I submit my report as under:
 - i. The Company completed dispatch of Postal Ballot Notice, electronically on Friday, 12th January, 2024, to its members whose names appeared in the register of members/list of beneficial holders as on Friday, 05th January 2024, (End of the Day) to their registered email ID.

- ii. The remote e-voting period remained open from Monday, 15th January, 2024 at 9.00 a.m. (IST) to Tuesday, 13th February, 2024 at 5.00 p.m. (IST).
- iii. The members whose names appeared in the register of members as on the "cut-off" date i.e., Friday, 5th January, 2024, (End of the Day) were entitled to vote on the resolution as set out in the Postal Ballot Notice of the Company.
- iv. The remote e-voting facility was blocked on Tuesday, 13th February, 2024 immediately after the completion of remote e-voting hours.
- 5. The details containing, *inter alia*, total votes received, votes cast in "favor "or "against" or abstained on the resolution that was put to vote, were generated from the e-voting website of KFin -i.e. https://evoting.kfintech.com and my report is based on such reports generated.
